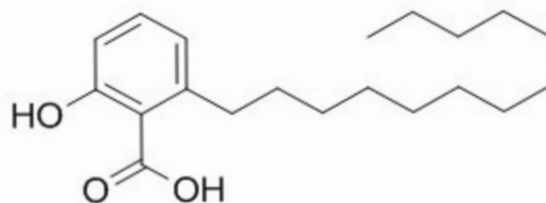

Ginkgolic acid C13:0 has a wide antimicrobial spectrum against E.coli and bacillus subtilis who are bacteria, and penicillium, penicillium purpurogenum, penicillium camemberti and aspergillus niger who are fungus, and the MIC of it against E.coli, bacillus subtilis and penicillium is 7.5, 15, 25 mg/mL separately. It is a natural anticariogenic agent in that it exhibits antimicrobial activity against S. mutans and suppresses the specific virulence factors associated with its cariogenicity. Ginkgolic acid C13:0 exhibits the high α -glucosidase inhibitory activity; Ginkgolic acid C13:0 represents a new kind of molluscicide agent, it has a pronounced effect on snail mitochondria with gross ultrastructural changes.

and can be explored as plant-derived antiparasitic for the control of *Pseudodactylogyrus*. Ginkgolic acid C13:0 has a wide antimicrobial spectrum against *E.coli* and *Bacillus subtilis* who are bacteria, and *Penicillium*, *Penicillium purpurogenum*, *Penicillium camemberti* and *Aspergillus niger* who are fungi, and the MIC of it against *E.coli*, *Bacillus subtilis* and

Ginkgolic acid (C13:0) exhibits the high α -glucosidase inhibitory activity.

Ginkgolic acid C13:0 represents a new kind of molluscicide agent, it has a pronounced effect on snail mitochondria with gross ultrastructural changes, it can inhibit the gene expression of four mitochondrial enzymes including cytochrome c oxidase, adenosine triphosphate (ATP) synthase, cytochrome b and dihydronicotinamide adenine dinucleotide (NADH) dehydrogenase, suggests that snail mitochondria is a potential target for the molluscicidal activity of ginkgolic acid C13:0 [4]

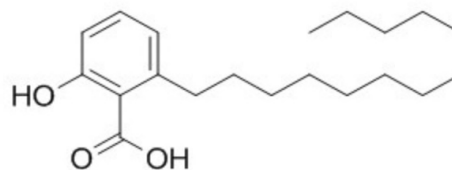
