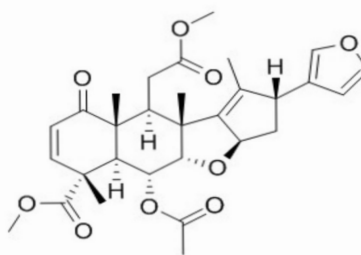

2. Nimbin requires to elicit a 50% inhibition of this steroid hydroxylase activity in the three insect species examined ranged from approximately 2×10^{-5} to 1×10^{-3} .
3. Nimbin shows anti-feedant activity and toxicity against larvae of three species of Lepidoptera, *Spodoptera litoralis* (Boisd), *Spodoptera frugiperda* (FE Smith) and *Helicoverpa armigera* (Hübner) and nymphs of the locusts *Schistocerca gregaria* (Forskål) and *Locusta migratoria* (L).

Nimbin inhibits the ecdysone 20-monooxygenase (E-20-M) in three insect species in a dose-dependent fashion. [2]

Nimbin shows anti-feedant activity and toxicity against larvae of three species of Lepidoptera, *Spodoptera littoralis* (Boisd), *Spodoptera frugiperda* (FE Smith) and *Helicoverpa armigera* (Hübner) and nymphs of the locusts *Schistocerca gregaria* (Forskål) and *Locusta migratoria* (L). [3]

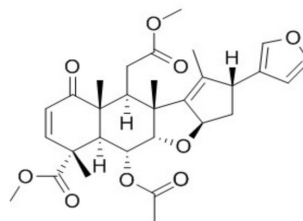
