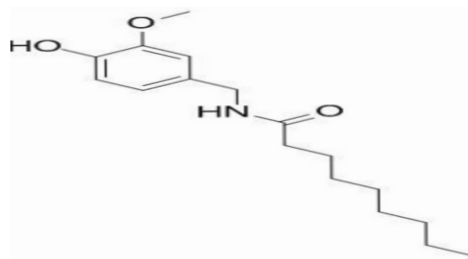

BIOLOGICAL ACTIVITY OR INHIBITORS

Nonivamide and capsaicin are novel skin permeation enhancers for indometacin.[1]

Nonivamide has antioxidant activity, it has the efficacy to protect linoleic and cholesterol against free radical attack.[2]

Nonivamide can enhance miRNA let-7d expression and decrease adipogenesis peroxisome proliferator activated receptor γ (PPAR γ) expression in 3T3-L1 cells; it may be effective anti-obesity agents by reducing energy intake, enhancing energy metabolism, decreasing serum triacylglycerol content, and inhibiting adipogenesis via activation of the transient receptor potential cation channel subfamily V member 1 (TRPV1). Nonivamide possesses similar anti-inflammatory potential as capsaicin and t-pellitorine ,it exploits an anti-inflammatory effect by inhibiting the EC-LPS induced activation of the MAPK pathway in U-937 macrophages, in addition, the TRP channel activation plays a role in the anti-inflammatory capacity of capsaicin and nonivamide. 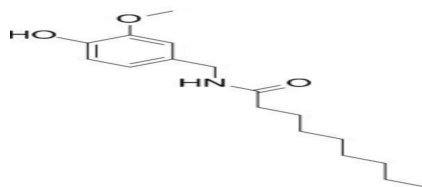
