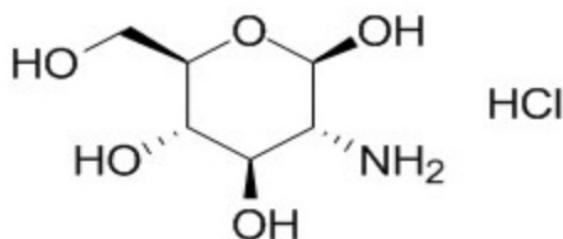

D-Glucosamine hydrochloride (GlcN67HCl) is an endogenous amino monosaccharide synthesized from glucose that is useful in the treatment of joint diseases in both humans and animals. [1]

Fucoxanthin is an effective anti-arthritis agent through an antiinflammation mechanism, fucoxanthin may enhance therapeutic effect of glucosamine hydrochloride on rat arthritis through mechanism of antiinflammation.[2]

D-glucosamine hydrochloride has antimicrobial effect on the common 21 strains of food spoilage microorganisms, it could as preservative agent was used to preserve nature eleo juice.[3]

D-Glucosamine Hydrochloride has antitumor effects. [4]

D-glucosamine hydrochloride induces cell apoptosis by blocking of cell-cycle.[5]

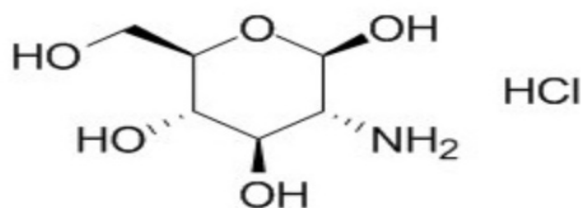
