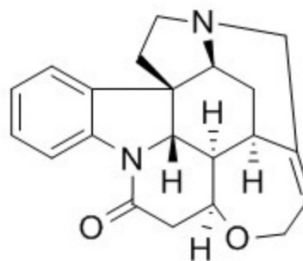

Strychnine and bicuculline have inhibitory effects on GABA- and glycine-induced responses.[1]
Strychnine can block binaural inhibition in lateral superior olivary neurons.[2]
Strychnine facilitates learning by affecting posttrial neurobiological processes underlying memory storage. [3]
Strychnine-insensitive glycine site NMDA antagonist (R)-HA-966 have neuroprotective effects in an experimental model of Parkinson's disease.[4]
Strychnine insensitive glycine receptor has anticonvulsant properties.[5]
Strychnine decreases the voltage-dependent Ca²⁺ current of both Aplysia and frog ganglion neurons.[6]

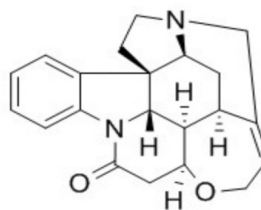
