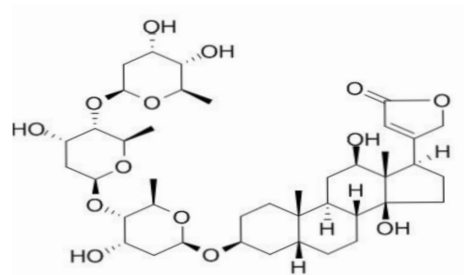

Digoxin is a cardiac glycoside, it does not reduce overall mortality, but it reduces the rate of hospitalization both overall and for worsening heart failure, these findings define more precisely the role of digoxin in the management of chronic heart failure.[1]

Digoxin and other cardiac glycosides can inhibit hypoxia-inducible factor 1 (HIF-1) α synthesis and block tumor growth.[2]

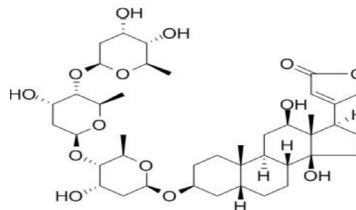
