

Treatment with the antioxidant dl-alpha-tocopherol can prevent cardiomyocyte/capillary mismatch, and to some extent also myocardial fibrosis in rats with renal failure.[1] DL-alpha-tocopherol acetate protects endothelial cell membranes from oxidative damage and disruption and limits the magnitude of haemorrhage and its spread from the subependyma into the ventricles.[2]

DL-alpha-tocopherol protects human skin fibroblasts against the cytotoxic effect of UVB, and its mechanism seems to be related to inhibition of UV-induced lipid peroxidation or to the antioxidation effect of dl-alpha-tocopherol. [3]

DL-alpha-tocopherol, a potent inhibitor of phorbol ester induced shape change of erythro- and megakaryoblastic leukemia cells.[4]

Pyridine, Methanol, Ethanol, Hot water, etc.

HPLC METHOD (11)

Mobile phase: Acetonitrile-Methanol-Chloroform=60:25:15, containing 0.01% Tert-butylated hydroxytoluene.

Flow rate: 1.0 ml/min;

Column temperature: Room Temperature;

The wave length of determination: 294 nm.

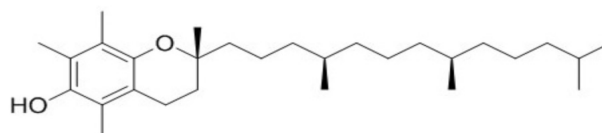
