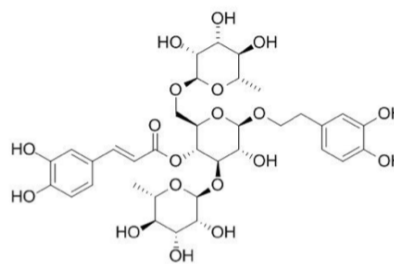

BIOLOGICAL ACTIVITY OR INHIBITORS

Poliumoside is one of the major phenylethanoid glycosides (PhGs) isolated from *Callicarpae Caulis et Folium* (CCF) which is a traditional Chinese medicine used for hemostasis in clinic; hydrolysis, hydroxylation, acetylation, sulfation, hydration, reduction, dehydrogenation and dimethylation were the major metabolic pathways of poliumoside. ^[1]

Poliumoside can inhibit Biofilm-forming *Staphylococcus aureus* in mice, has some antibacterial activity.^[2]

Poliumoside has oxidant scavenging capacity.^[3]

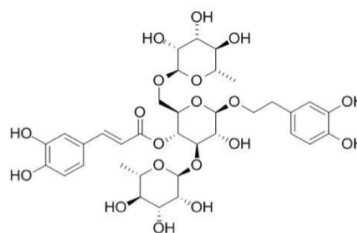
