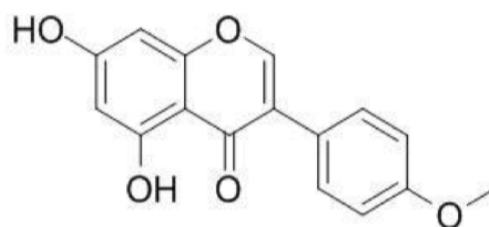

## BIOLOGICAL ACTIVITY OR INHIBITORS

---

Biochanin A and genistein inhibit both serum and EGF-stimulated growth of LNCaP and DU-145 cells (IC<sub>50</sub> values from 8.0 to 27 micrograms/ml for serum and 4.3 to 15 micrograms/ml for EGF), suggest that the mechanism of action of genistein and biochanin A does not depend on inhibition of EGF receptor tyrosine autophosphorylation, but on a more distal event in the EGF receptor-mediated signal transduction cascade.<sup>[1]</sup>

Biochanin A, morin, phloretin, and silymarin all inhibit P-glycoprotein (P-gp)-mediated cellular efflux and the mechanism of the interaction involved, at least in part, a direct interaction.<sup>[2]</sup>

Biochanin A shows anti-proliferative and anti-inflammatory activities through the inhibition of iNOS expression, p38-MAPK and ATF-2 phosphorylation and blocking NFκB nuclear translocation. <sup>[3]</sup>

BiochaninA, a phytoestrogen compound has protective effects against L-glutamate- induced cytotoxicity in a PC12 cell line, it may act as an antiapoptotic agent in order to perform its protective function.<sup>[4]</sup>

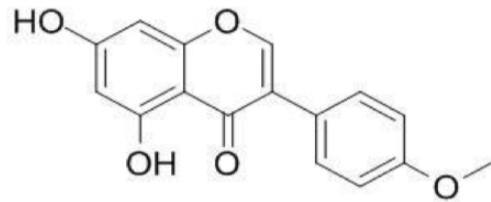
