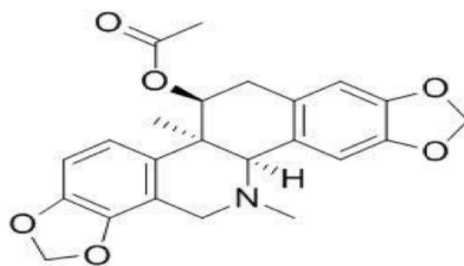

Acetylcorynoline has anti-inflammatory properties, it also has potential to improve parkinson's disease, it may exert its effects by decreasing egl-1 expression to suppress apoptosis pathways and by increasing rpn5 expression to enhance the activity of proteasomes.^[1]

Acetylcorynoline may be one of the potent immunosuppressive agents through the blockage of dendritic cells maturation and function.^[2]

Acetylcorynoline has protective action against experimental liver injury in mice.^[3]

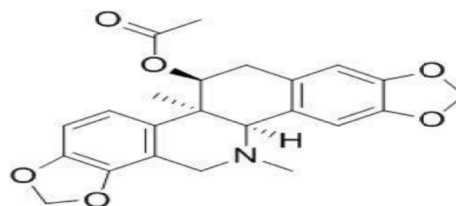
