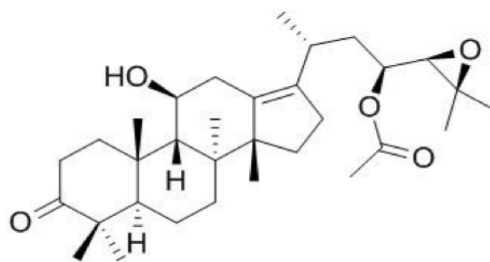

BIOLOGICAL ACTIVITY OR INHIBITORS

Alisol B 23-acetate, a protostane-type triterpene isolated from the *Alismatis Rhizoma*, it obviously inhibits proliferation of the three ovarian cancer cell lines, down-regulates the protein levels of CDK4, CDK6, and cyclin D1, and blocks the cell cycle progressions in G1 phase; suggests that it possesses anti-proliferation, anti-migration and anti-invasion activities as a single agent on ovarian cancer cells.^[1]

Alisol B 23-acetate could be a transporter substrate for P-glycoprotein (P-gp), it is also a partial non-competitive inhibitor of P-gp when verapamil was used as a substrate, suggests that it may be a potential MDR reversal agent and could serve as a lead compound in the development of novel drugs.^[2]

Alisol B 23-acetate shows moderate cytotoxic activities against B16-F10 and HT1080 tumor cells.^[3]

Alisol B 23-acetate produces promotive effect on liver regeneration, due to FXR-mediated regulation of genes involved in hepatocyte proliferation and hepato-protection, it has the potential to be a novel therapeutic option for facilitating efficient liver regeneration in patients subjected to liver resection.^[4]

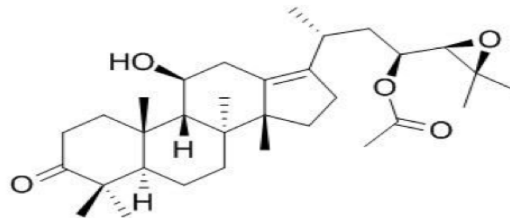
