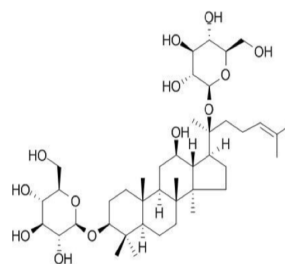

## BIOLOGICAL ACTIVITY OR INHIBITORS

---

20(S)-Protopanaxadiol may inhibit the proliferation of Siha cells, and its mechanism may be related to up-regulating the expressions of p53, p21, and autophagy related gene Beclin 1 and MAP1-LC3, and down-regulating the expression of cyclin-E.<sup>[1,2]</sup>

20 (S)-Protopanaxadiol may induce the apoptosis of PC3 cells, and its mechanism may be related to the down-regulation of Bcl-2 protein and the up-regulation of  $\gamma$ H2Ax protein expression.<sup>[3]</sup>

20(S)-Protopanaxadiol may induce the apoptosis of Siha cells, and its mechanism may be related to the up-regulation of bax expression, and the up-regulation and activation of caspase family.<sup>[4,5]</sup>

20(S)-Protopanaxadiol saponins have protective effects on acute myocardial ischemia including improving heart function, decreasing cardiac oxygen consumption and increasing myocardial blood flow, etc.<sup>[6]</sup>

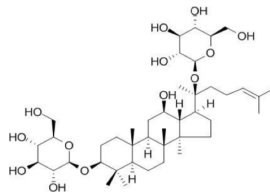
