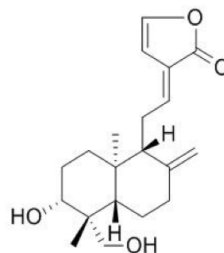

BIOLOGICAL ACTIVITY OR INHIBITORS

Dehydroandrographolide and andrographolide, two natural diterpenoids isolated from *Andrographis paniculata* possess activity against HBV DNA replication with IC₅₀ values of 22.58 and 54.07 μM and low SI values of 8.7 and 3.7, respectively.^[1]

Dehydroandrographolide can enhance innate immunity of intestinal tract by up-regulating the expression of hBD-2 through the p38 MAPK pathways.^[2]

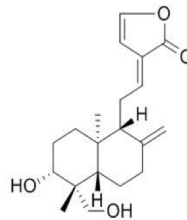
