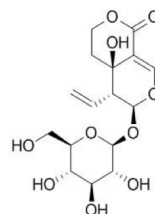

## BIOLOGICAL ACTIVITY OR INHIBITORS

---

Swertiamarin, a secoiridoid glycoside was found to contain a major constituent of the extract, possesses significant antioxidant and hepatoprotective properties against d-GalN induced hepatotoxicity given at 100 and 200 mg/kg body weight orally for 8 days, which might be due to its in vitro antioxidant activity.<sup>[1]</sup>

Swertiamarine has wound healing activity via the stimulation of collagen production and its mitotic activity, it also exhibits cytoprotective effects.<sup>[2]</sup>

Swertiamarin can significantly increase high-density lipoprotein (HDL) levels and it shows a significant lipid-lowering effect, as well as a high antiatherogenic potential, overall swertiamarin is an effective lipid-lowering lead compound and can be useful for preventing atherosclerosis. <sup>[3]</sup>

Swertiamarin possesses both peripheral and central antinociceptive activity.<sup>[4]</sup> Swertiamarin has anti-inflammatory activity, it inhibits the development of arthritis by modulating NF- $\kappa$ B/I $\kappa$ B and JAK2/STAT3 signaling, suggests that swertiamarin acts as an anti-rheumatic agent.<sup>[5]</sup>

Swertiamarin has anti-diabetic effects, the anti-diabetic effect of swertiamarin is due to gentianine, an active metabolite of swertiamarin.<sup>[6]</sup>

Swertiamarin stimulates gastric emptying and gastrointestinal motility by inhibiting the dopamine D2 receptor<sup>[7]</sup>

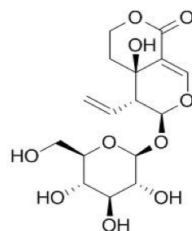
