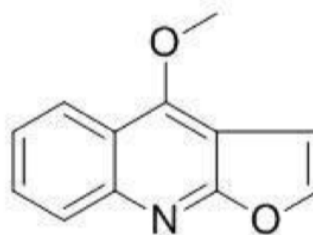

BIOLOGICAL ACTIVITY OR INHIBITORS

Dictamnine and gamma-fagarine have mutagenic activities, they have specific activities (His+/microgram) of about 50-70 revertant colonies in strain TA100, while in strain TA98 there were about 30-50 revertant colonies.^[1]

Dictamnine has good antifungal activity alone and in combination with fluconazole against *Candida albicans*.^[2]

Dictamnine at higher concentrations ($\geq 100 \mu\text{M}$) has potential hepatotoxicity, the cell membrane damage and mitochondrial membrane damage may be involved in the dictamnine-induced hepatotoxicity mechanism.^[3]

Dictamnine has photoinduced genotoxicity.^[4]

Dictamnine shows anti-inflammatory effect.^[5]

Dictamnine shows anticholinesterase activity.^[6]

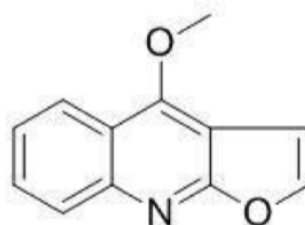
