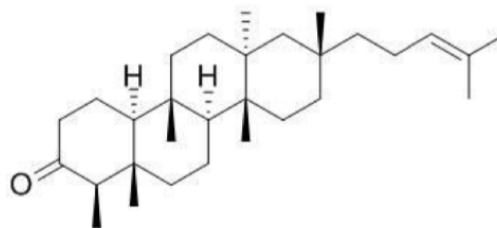

Shionone has anti-inflammatory effect, the mechanism is related to decrease the phosphorylation level of ERK1/2 protein and I $\kappa$ B $\alpha$  and the protein expression of i NOS.<sup>[1]</sup>

Shionone can inhibit the activity of ubiquitin-specific protease 2 (USP2) and provide a lead compound for future development of new USP2 inhibitors.<sup>[2]</sup>

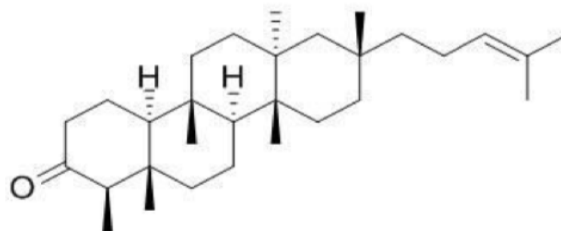
