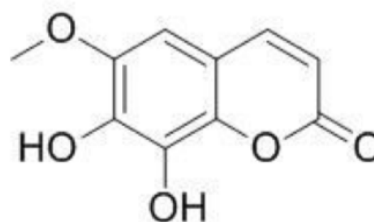

## BIOLOGICAL ACTIVITY OR INHIBITORS

---

Fraxetin has dual-antioxidative functions, it has direct protective properties against low-density lipoprotein oxidation at lower concentrations, and higher concentrations of fraxetin induce antioxidant enzymes via Nrf2/ARE activation.<sup>[1]</sup>

Fraxetin prevents rotenone-induced apoptosis by induction of endogenous glutathione in human neuroblastoma cells.<sup>[2]</sup>

Fraxetin has antihyperglycemic effect on hepatic key enzymes of carbohydrate metabolism in streptozotocin-induced diabetic rats.<sup>[3]</sup>

Fraxetin has inhibitory effect on various bacterial strains, it can disrupt nucleic acid and protein synthesis by preventing topoisomerase from binding to DNA.<sup>[4]</sup>

Fraxetin exhibits potent protective effects against CCl<sub>4</sub> induced oxidative stress and hepatic fibrosis.<sup>[5]</sup>

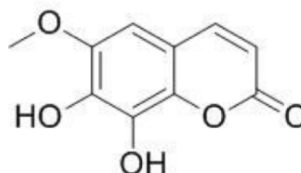
