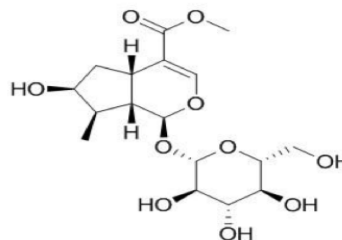

BIOLOGICAL ACTIVITY OR INHIBITORS

Loganin has neuroprotective properties, it protects against hydrogen peroxide-induced apoptosis by inhibiting phosphorylation of JNK, p38, and ERK 1/2 MAPKs in SH-SY5Y cells, it may be a potential therapeutic agent for the treatment of neurodegenerative diseases.^[1]

Loganin inhibits advanced glycation endproduct formation and the expression of its receptor, and nuclear factor-kappa B-induced inflammation in the hepatic tissue of db/db mice; hyperglycemia and dyslipidemia are ameliorated in both the serum and hepatic tissue in loganin-treated db/db mice; loganin exhibits protective effects against hepatic injury and other diabetic complications associated with abnormal metabolic states and inflammation caused by oxidative stress and advanced glycation endproduct formation.^[2]

Loganin may have anti-amnesic activity that may hold significant therapeutic value in alleviating certain memory impairments observed in Alzheimer's disease, it can significantly inhibit acetylcholinesterase activity in the hippocampus and frontal cortex. ^[3]

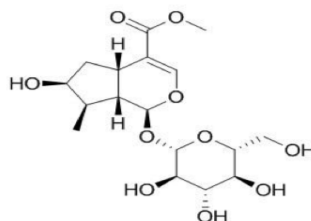
