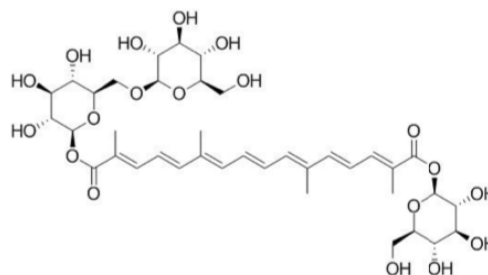

### BIOLOGICAL ACTIVITY OR INHIBITORS

---

Crocin has anti-inflammatory and anti-apoptotic effects against gastric ischemia- reperfusion injury in rats, the effect of crocin is mainly mediated by reducing the protein expression of iNOS and caspase-3.<sup>[1]</sup>

Crocin can ameliorate CCl<sub>4</sub>-induced liver injury via inhibition of inflammatory cytokines, caspase3 and oxidative stress along with modulation of liver metabolizing enzymes favoring elimination of CCl<sub>4</sub> toxic metabolite.<sup>[2]</sup>

Crocin has antihyperlipidemic effect, may be due to the inhibition of pancreatic lipase and crocin, and its metabolite, crocetin, can improve hyperlipidemia. <sup>[3]</sup>

Crocin has antidepressant effects by increasing CREB, BDNF and VGF levels in hippocampus.<sup>[4]</sup>

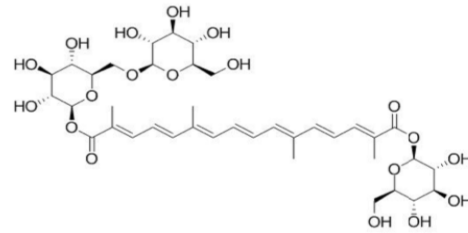
