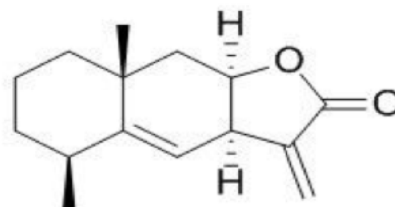

BIOLOGICAL ACTIVITY OR INHIBITORS

Alantolactone, an allergenic sesquiterpene lactone, has significant antitumor effects on malignant tumor cells, it is a promising potent agent to fight against CML cells via the inhibition of the NF- κ B signaling pathway and depletion of the Bcr/Abl protein.^[1]

Alantolactone induces cell apoptosis partially through down-regulation of testes-specific protease 50 expression.^[2]

Alantolactone can suppress inducible nitric oxide synthase and cyclooxygenase-2 expression by down-regulating NF- κ B, MAPK and AP-1 via the MyD88 signaling pathway in LPS-activated RAW 264.7 cells, it may provide a useful therapeutic approach for inflammation-associated diseases.^[3]

Alantolactone inhibits cell proliferation by interrupting the interaction between Cripto-1 and activin receptor type II A in activin signaling pathway.^[4]

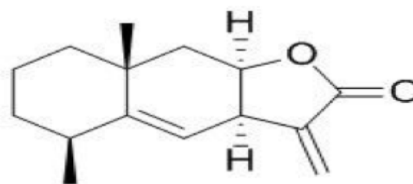
