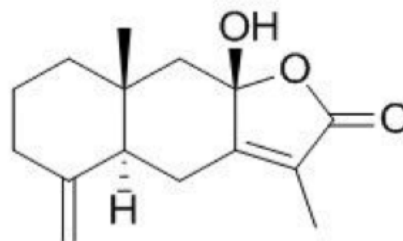

BIOLOGICAL ACTIVITY OR INHIBITORS

Atractylenolide III is the major bioactive component of *Atractylodes lancea*, it inhibits histamine release, suppresses activation of p38 mitogen-activated protein kinase, C-Jun-N-terminal protein kinase, and nuclear factor- κ B in stimulated HMC-1 cells, and suppresses the activation of caspase-1 and the expression of receptor interacting protein-2, suggests that atractylenolide III may control immunological reactions by regulating the cellular functions of IL-6 in mast cells.^[1]

Atractylenolide III and atractylenolide I have anti-inflammatory activity through inhibition of nuclear factor- κ B and mitogen-activated protein kinase pathways in mouse macrophages, can inhibit Lipopolysaccharide-induced TNF- α and NO production in macrophages.^[2,3]

Atractylenolide III can induce apoptosis in human lung carcinoma A549 cells via mitochondria-mediated death pathway, indicates that it is a potential candidate for treatment of human lung carcinoma.^[4]

Atractylenolide III (LD50, 103.3 mg/m²) and atractylon (136.2 mg/m²) are potential house dust mite control agents, they are five and four times more toxic than Deet and 1.7- and 1.3-fold more active than dibutyl phthalate, respectively, based on 24 h LD50 values. ^[5]

Atractylenolide III has neuroprotection against glutamate-induced neuronal apoptosis via inhibiting caspase signaling pathway.^[6]

Atractylenolide III has gastroprotective activity on ethanol-induced gastric ulcer in vitro and in vivo.^[7]

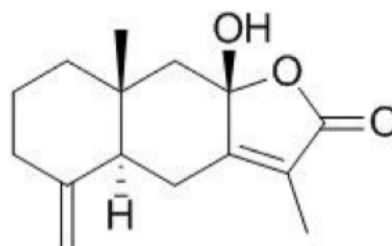
