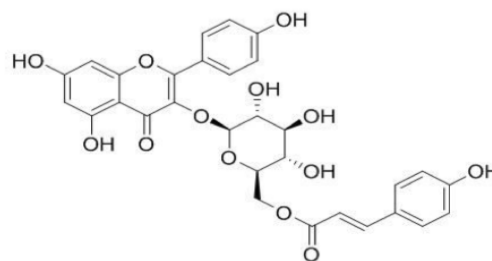

### BIOLOGICAL ACTIVITY OR INHIBITORS

---

Tiliroside, a dietary flavonol glycoside from the flowers of *Tilia argentea* (linden), shows a hepatoprotective effect against D-galactosamine (D-GalN)/lipopolysaccharide (LPS)-induced liver injury in mice.<sup>[1]</sup>

Tiliroside has anti-inflammatory and antioxidant activity, it can significantly reduce the oedema and leukocyte infiltration induced by 12-O-tetradecanoylphorbol 13-acetate (TPA).<sup>[2]</sup>

Tiliroside shows very potent anti-complement activity (IC<sub>50</sub>=5.4 × 10<sup>(-5)</sup> M) on the classical pathway of the complement system. <sup>[3]</sup>

Tiliroside and gnapthaliin are antioxidants against in vitro Cu<sup>2+</sup>-induced LDL oxidation in the same order of magnitude compared to that of the reference drug, probucol.<sup>[4]</sup>

Tiliroside has anti-diabetic effects, the effects at least partially mediated through inhibitory effects on carbohydrate digestion and glucose uptake in the gastrointestinal tract.<sup>[5]</sup>

Tiliroside has shown in vivo anti-inflammatory activity; it also can inhibit neuroinflammation in BV2 microglia through a mechanism involving TRAF-6-mediated activation of NF-κB and p38 MAPK signalling pathways, these activities are possibly due, in part, to the antioxidant property of this compound.<sup>[6]</sup>

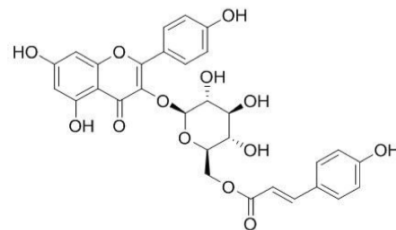
