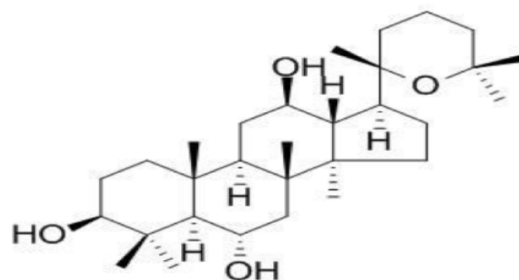

BIOLOGICAL ACTIVITY OR INHIBITORS

Panaxatriol saponins (PTS), the main constituents extracted from *Panax notoginseng*, a Chinese herbal medicine, has been shown to be an effective agent on various diseases, it is an inducer of thioredoxin-1 (Trx-1), it prevents 1-methyl-4-phenylpyridinium ion-induced neurotoxicity and has pluripharacological properties in the protection against Parkinson's disease (PD) including enhancing antioxidant activity, acting as neurotrophic factor, modulating inflammation and inhibiting mitochondria-mediated apoptosis.^[1,2]

Panaxatriol saponins has been shown to be efficacious in the prevention and treatment of cerebrovascular diseases in China, it may activate endogenous cytoprotective mechanism against OGD-Rep induced oxidative injury via the activation of PI3K/Akt and Nrf2 signaling pathway.^[3]

Panaxatriol saponins shows a protective effect on focal cerebral ischemia in rat brain by alleviating cerebral edema, up regulating the expression of HSP70, down regulating transferrin and maintaining blood brain barrier.^[4]

Panaxatriol ameliorates ischemia/reperfusion (I/R) -induced myocardial damage and this protection is caused by reducing oxidative stress.^[5]

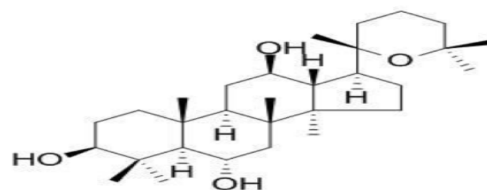
