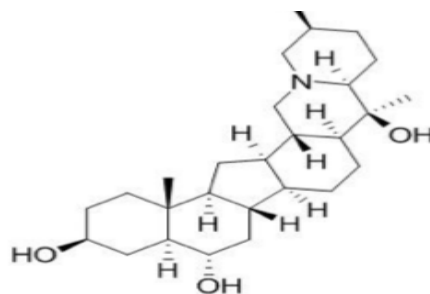

### BIOLOGICAL ACTIVITY OR INHIBITORS

Peimine has good anti-inflammatory effects in vivo, it inhibits the production of inflammatory cytokines induced by LPS through blocking MAPKs and NF- $\kappa$ B signaling pathways.<sup>[1]</sup>

Peimine and peiminine have antitussive and sedative actions, the former action being suspected to be central in nature.<sup>[2]</sup>

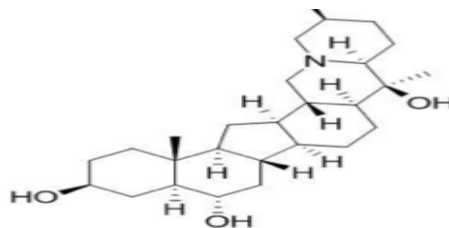
