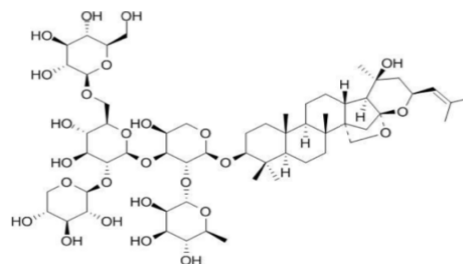

### BIOLOGICAL ACTIVITY OR INHIBITORS

Jujuboside A (JuA), one constituent of Chinese herbal medicine Ziziphus jujuba Mill Var spinosa (Bunge) Hu; a high dose of JuA can inhibit the hyperactivity of hippocampal CA1 area induced by penicillin sodium.<sup>[1]</sup>

Jujuboside A possesses antianxiety, antioxidant, and anti-inflammatory effects, it can notably reduce the damage cause by ISO via promoting the phosphorylation of PI3K, Akt, and mTOR and inhibiting LC3 conversion, which may be a potential choice for the treatment of heart diseases.<sup>[2]</sup>

Jujuboside A has inhibitory effects on Glu-mediated excitatory signal pathway in hippocampus and probably acts through its anti-calmodulin action.<sup>[3]</sup>

Jujuboside A, a neuroprotective agent, can ameliorates behavioral disorders of the dementia mouse model induced by A $\beta$  1–42.<sup>[4]</sup>

Jujuboside A has sedative and anticonvulsant effects.<sup>[5]</sup>

Jujuboside A and Zolpidem can inhibit gamma aminobutyric acid type A receptor.<sup>[6]</sup>

Jujuboside A has inhibitory effect on proliferation of human normal liver cells,hepatic stellate cells and human hepatoma cells.<sup>[7]</sup>

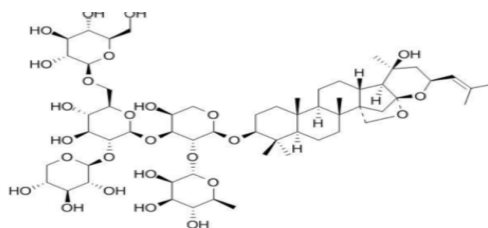
