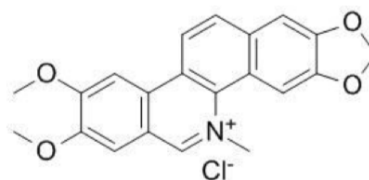

BIOLOGICAL ACTIVITY OR INHIBITORS

Nitidine chloride, a natural phytochemical alkaloid derived from *Zanthoxylum nitidum* (Roxb) DC, exerts potent anticancer activity through STAT3 signaling cascade, it can dose dependently suppress VEGF-induced endothelial cell proliferation, migration, and tubular structure formation in vitro and dramatically reduce VEGF-triggered neovascularization in mouse cornea and Matrigel plugs in vivo; suggests that nitidine chloride is a promising anticancer drug candidate as a potent STAT3 signaling inhibitor.^[1]

Nitidine Chloride can inhibit breast cancer cells migration and invasion both in vitro and in vivo, it could have potential as a novel anti-metastasis drug to breast cancer.^[2]

Nitidine chloride exerts an anti-inflammatory property by inhibiting TNF- α , IL-1 β , and IL-6 production in association with reduced NF- κ B and MAPK signaling pathways in RAW 264.7 cells, these results reveal a novel role of nitidine chloride in regulation of inflammatory diseases. ^[3]

Nitidine chloride has protective effects on rats during myocardial ischemia/reperfusion.^[4]

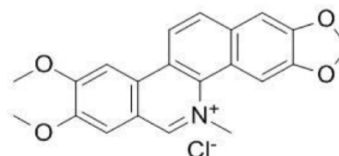
