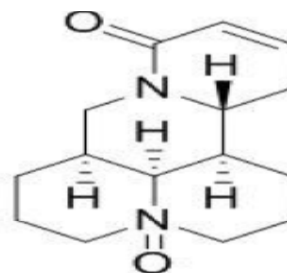

BIOLOGICAL ACTIVITY OR INHIBITORS

Oxysophocarpine shows a significant anti-inflammatory effect in the mouse ear swelling test, it also attenuates inflammatory pain by suppressing the levels of phosphorylation of extracellular signal-regulated kinase 1/2, cyclooxygenase-2, prostaglandin E2, tumor necrosis factor α , interleukin-1 beta and interleukin-6.[1]

Oxysophocarpine has significant neuroprotective effects that can be attributed to inhibiting endoplasmic reticulum (ER) stress-induced apoptosis.[2]

Oxysophocarpine has anti-nociceptive effects on the central and peripheral nervous systems, it can induce anti-nociception and increase the expression of GABA $\text{A}\alpha$ 1 receptors in mice.[3]

Oxysophocarpine exerts anticonvulsant and neuroprotective effects on pilocarpine (PILO)-treated mice.[4]

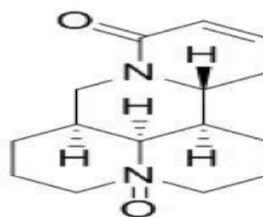
