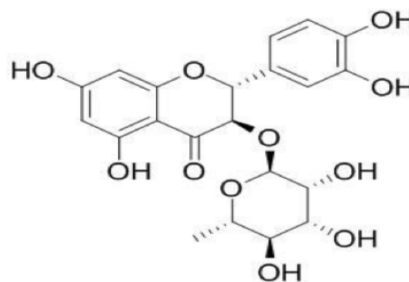

### BIOLOGICAL ACTIVITY OR INHIBITORS

Astilbin may act as an efficient therapeutic agent for arthritis like cyclosporine A but with less toxicity, its mechanism includes a selective suppression on lymphocyte functions via reducing MMP and NO production.[1]

Astilbin can selectively facilitate the apoptosis of interleukin-2-dependent phytohemagglutinin-activated Jurkat cells, the characteristic of astilbin may be of great significance for the treatment of a variety of immunologically related diseases.[2]

Astilbin has insecticidal activity.[3]

Astilbin shows strong antioxidant activity.[4]

Astilbin alleviates contact hypersensitivity through a unique mechanism involving a negative cytokine regulation through stimulating IL-10, which is distinct from the immunosuppressant cyclosporin A.[5]

Astilbin prevents concanavalin A-induced liver injury by reducing TNF- $\alpha$  production and T lymphocyte adhesion.[6]

Astilbin has antibacterial activity, the minimal inhibitory quantity (MIQs) of astilbin ranges from 50 to 100 microg. [7]

Astilbin can exert an early renal protective role to diabetic nephropathy (DN), inhibit production of transforming growth factor-beta1 (TGF-beta1) and connective tissue growth factor (CTGF).[8]

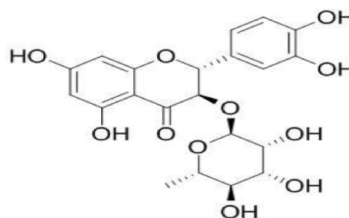
