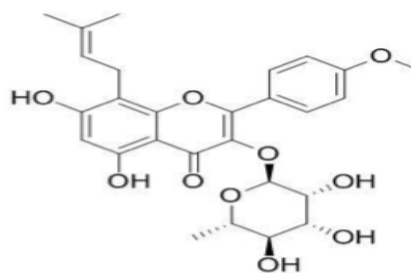

### BIOLOGICAL ACTIVITY OR INHIBITORS

Baohuoside I from Periplocae Cortex can inhibit the proliferation of Eca-109 cells, this effect associates with down-regulation expression of  $\beta$ -catenin,Cyclin D1,Survivin,and their proteins,which affects on the Wnt/ $\beta$ -catenin signaling pathway.[1]

Baohuoside I in combination with 5-FU exerted a synergistic effect on inhibiting proliferation and promoting apoptosis, this effect associated with decreased expression of Bcl-2 and increased expression of Bax.[2]

Baohuoside I exhibits anti-inflammatory and anti-cancer activities; reactive oxygen species-mediated mitochondrial pathway is involved in Baohuoside I-induced apoptosis in human non-small cell lung cancer. [3]

Baohuoside-1 is a novel immunosuppressive molecule, can inhibit lymphocyte activation in vitro and in vivo.[4]

Baohuoside aglycone possesses cardioprotective effect in prevention of ischemia/reperfusion injury and reduce the myocardial infraction, the mechnism is due to the reduction of the injury of free radicals.[5]

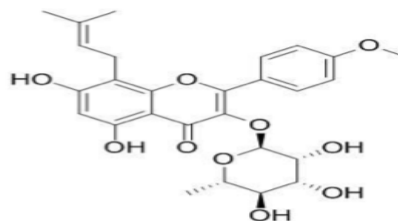
