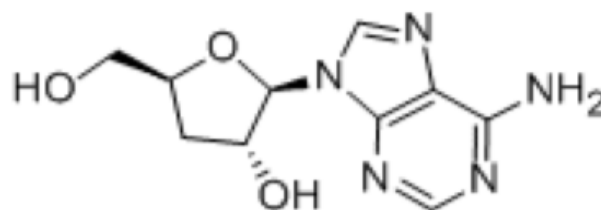

### BIOLOGICAL ACTIVITY OR INHIBITORS

Cordycepin is reported to possess many pharmacological activities including immunological stimulating, anti-cancer, anti-virus and anti-infection activities; cordycepin inhibits the production of NO production by down-regulation of iNOS and COX-2 gene expression via the suppression of NF- $\kappa$ B activation, Akt and p38 phosphorylation, thus, cordycepin may provide a potential therapeutic approach for inflammation-associated disorders.[1]

Cordycepin is a selective growth inhibitor against *Clostridium* spp.[2]

Cordycepin exerts inhibitory effects on the growth of mouse melanoma and lung carcinoma cells by stimulating adenosine A receptors on tumor cells. [3]

Cordycepin has antileukemic activity against terminal deoxynucleotidyl transferase- positive (TdT+) leukemic cells. [4]

Cordycepin has antifungal activity , it and related compounds may provide another avenue for the discovery of clinically useful antifungal drugs.[5]

Cordycepin exerts a potent neuroprotective function after cerebral ischemia/reperfusion.[6]

Cordycepin has neuroprotective effects to inhibit glutamate-induced oxidative and ER stress-associated apoptosis in hippocampal HT22 cells.[7]

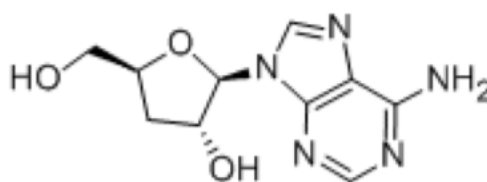
