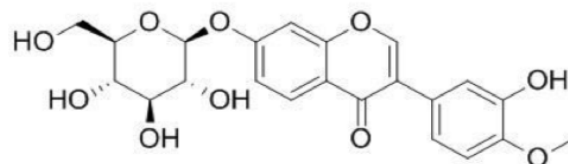

BIOLOGICAL ACTIVITY OR INHIBITORS

Triptonide shows cytotoxic activities against the majority of the human tumor cell lines^[1]

Triptonide has extensive suppressive effects on mouse immune function and its mechanism may be related to the reduction of Th/Ts ratio and the induction of Ts cells.^[2]

Triptonide has good anti-inflammatory and immunosuppressive actions, it can apparently inhibit auricle inflammation and capillary permeability, decrease the index of thymus and the clearance rate of charcoal particles and suppress the formation of spleen cell antibody, reduce the content of serum hemolysin and T-lymphocytes percentage in mice.^[3]

Triptonide can effectively induce apoptosis of Wnt-dependent cancer cells via C-terminal Transactivation Domain of β -catenin.^[4]

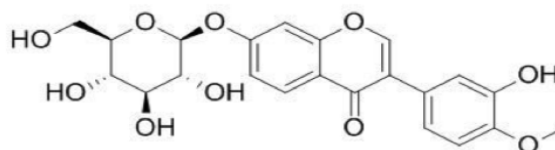
