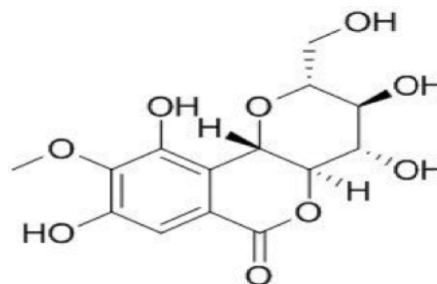

BIOLOGICAL ACTIVITY OR INHIBITORS

Bergenin has immunomodulatory effect, it shows anti-arthritic activity through possible modulation of Th1/Th2 cytokine balance.[1]

Bergenin shows hepatoprotective effects against galactosamine-intoxicated rat hepatocytes by inhibiting the release of glutamic pyruvic transaminase and sorbitol dehydrogenase as well as by increasing RNA synthesis.[2]

Bergenin has antifungal activity against some plant pathogenic fungi. [3]

Bergenin has antioxidant potential, it has regenerative effect on pancreatic β cells, hence, it possesses significant antidiabetic, hypolipidemic and antioxidant activity in Type 2 diabetic rats.[4]

Bergenin has consistent antinociceptive and anti-inflammatory properties, acting by the inhibition of IL-1 β and TNF- α production, and suggests its potential for the control of inflammatory pain.[5]

Bergenin is a potential anti-HIV agent of traditional Asian medicine, it also has antimicrobial activity.[6,7]

Bergenin has anticoagulant properties.[8]

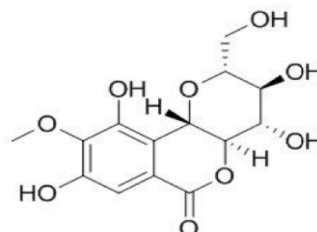
