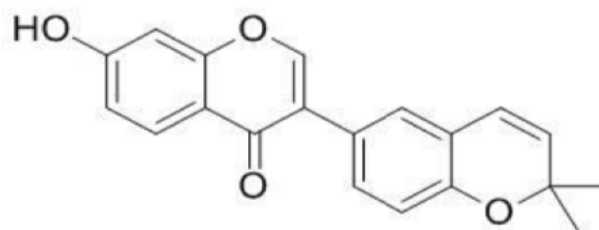

Corylin might stimulate bone formation or have potential activity against osteoporosis.[2]

*Psoralea corylifolia* L. (PCAE) has effects on the LPS-induced EMT were mediated by the inactivation of the NF- $\kappa$ B-SNAIL signaling pathway, PCAE suppresses cancer cell invasion and migration by inhibiting EMT; therefore, PCAE is a potentially effective dietary chemopreventive agent for malignant tumors since it inhibits metastasis. 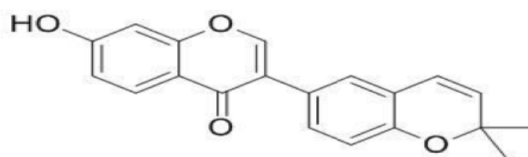
