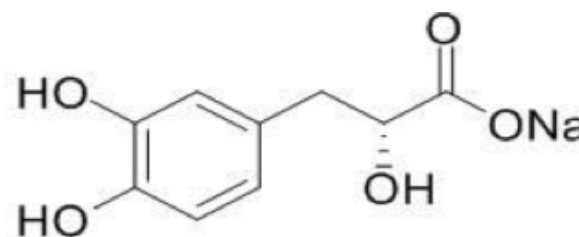

### BIOLOGICAL ACTIVITY OR INHIBITORS

---

Sodium danshensu (SDSS), the sodium salt of danshensu (DSS), has the neuroprotective effect against cerebral I/R injury, and the potential mechanism might to inhibition of apoptosis through activating the PI3K/Akt signal pathway. <sup>[1]</sup>

Sodium danshensu has a protective effect against the genotoxicity of cigarette smoke.<sup>[2]</sup>

Sodium danshensu shows a biphasic effects on vessel tension, while low dosage of sodium danshensu produces small contraction possibly through transient enhancement of Ca(2+) influx, high dosage produces significant vasodilation mainly through promoting the opening of non-selective K(+) channels and small-conductance calcium-sensitive K(+) channels in the vascular smooth muscle cells.<sup>[3]</sup>

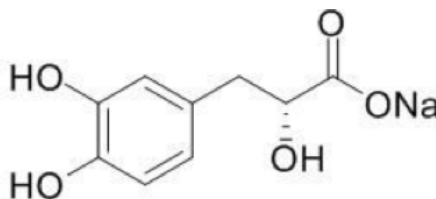
