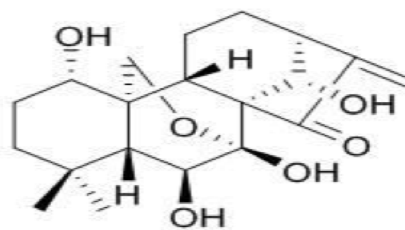

BIOLOGICAL ACTIVITY OR INHIBITORS

Oridonin inhibits the proliferation of cancer cells via apoptosis and cell cycle arrest with p53 playing a central role in several cancer types which express the wild-type p53 gene, it may be a novel, adjunctive therapy for a large variety of malignancies and probably represents one of the major, active components of PC-SPES(an eight herbal mixture that was shown to have activity against prostate cancer).^[1]

Oridonin may be a potential antileukemia agent that targets AE oncoprotein at residue D188 with low adverse effect, and may be helpful for the treatment of patients with t(8;21) acute myeloid leukemic (AML).^[2]

Oridonin confers protection against arsenic-induced toxicity through activation of the Nrf2-mediated defensive response, and the feasibility of using natural compounds targeting Nrf2 as a therapeutic approach to protect humans from various environmental insults that may occur daily.^[3]

Oridonin remarkably suppresses activations of Akt/mTOR, Raf/MEK and STAT5 pathway in these primary specimens and oridonin with imatinib exerts synergetic suppressive effects on mTOR, STAT5 and LYN signaling in one imatinib resistant patient specimen. ^[4]

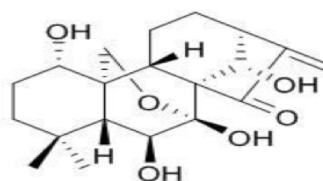
