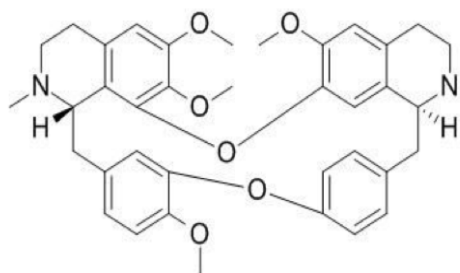

BIOLOGICAL ACTIVITY OR INHIBITORS

Tetraandrine protects hepatocytes by inhibiting calcium release-activated calcium current (I(CRAC)), which is not related to I(K) and I(K1).^[1]

Tetraandrine can inhibit inward rectifying potassium current in cultured bovine aortic endothelial cells.^[2]

Tetraandrine exerts antifibrotic effects in both HSC-T6 cells and in rats with dimethylnitrosamine (DMN)-induced fibrosis. ^[3]

Tetraandrine is a potent multidrug resistance (MDR)-reversing agent in vitro and in vivo, its mechanism of action is via directly binding to P-gp and increasing intracellular vincristine accumulation.^[4]

Tetraandrine is an antitumor alkaloid isolated from the root of *Stephania tetrandra*, it arrests cells in G(1) by convergent mechanisms, including down-regulation of E2F1 and up-regulation of p53/p21(Cip1).^[5]

Tetraandrine inhibits activation of rat hepatic stellate cells stimulated by transforming growth factor- β in vitro via up-regulation of Smad 7.^[6]

Tetraandrine shows anti-oxidant activity, anti-inflammatory and immunosuppressive activity.^[7]

Mobile phase: Methanol-1.0 g/L Sodium 1-octanesulfonate in water (pH 3.0, adjusted by glacial acetic acid)=65:35;

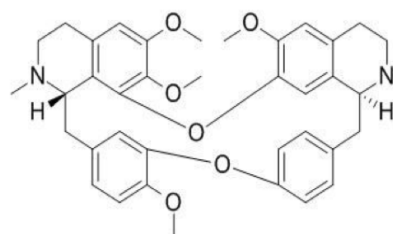
