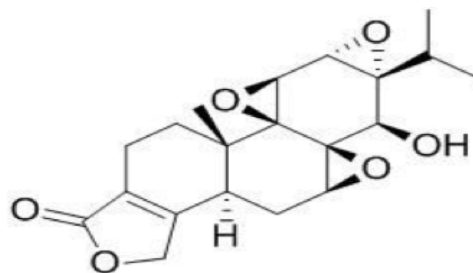

BIOLOGICAL ACTIVITY OR INHIBITORS

Triptolide is the major active component in the extract of *Tripterygium wilfordii* Hook. f (TWHf) that inhibits antigen or mitogen-induced T cell proliferation, triptolide induces T cell apoptosis through activating caspases, and suggest the growth arrest and apoptotic effect of triptolide may contribute to the immunosuppressive activity of TWHf extract.^[1]

Triptolide has antitumor properties, it has a broad spectrum of activity against tumors that contain both wild-type and mutant forms of p53.^[2]

Triptolide is a promising immunosuppressive and anti-inflammatory agent, it has inhibitory effects on a variety of proinflammatory cytokines and mediators and on the expression of adhesion molecules by endothelial cells, it is effective for the treatment of a variety of autoimmune diseases and in prevention of allograft rejection and graft-versus-host disease in both animals and humans; moreover, triptolide possesses toxicity and male anti-fertility effect.^[3]

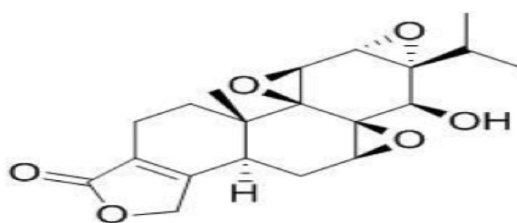
