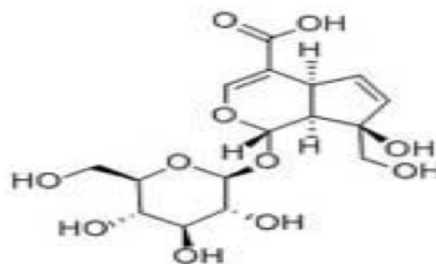

BIOLOGICAL ACTIVITY OR INHIBITORS

Monotropein has anti-inflammatory activity, it exerts protective effects against IL-1 β -induced apoptosis and catabolic responses on osteoarthritis chondrocytes.^[1]

Monotropein contributes to the antinociceptive and anti-inflammatory action of *Morinda officinalis* root, monotropein (at 20, 30 mg/kg/d, p.o.) can significantly reduce stretching episodes and prolong action time in mice, it also can significantly reduce acute paw edema by carrageenan in rats.^[2]

Monotropein can increase osteoblastic bone formation and prevent bone loss in ovariectomized mice, it may serve as a new candidate or a leading compound for antiosteoporosis. ^[3]

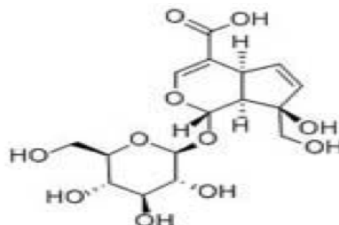
