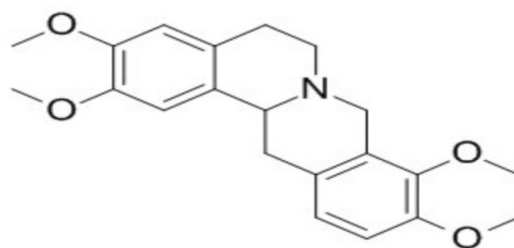

BIOLOGICAL ACTIVITY OR INHIBITORS

Levo-tetrahydropalmatine (L-THP), a dopamine (DA) D(1) and D(2) receptor antagonist purified from the Chinese herb *Stephanie*, appears to be effective in attenuating cocaine self-administration, cocaine-triggered reinstatement and cocaine-induced conditioned place preference in preclinical animal models; L-THP slightly elevates extracellular nucleus accumbens DA by itself, but dose-dependently potentiates cocaine-augmented DA, suggesting that a postsynaptic, rather than presynaptic, DA receptor antagonism underlies L-THP's actions on cocaine reward; together, the present data support the potential use of L-THP for treatment of cocaine addiction.^[1]

dl-Tetrahydropalmatine (dl-THP) has been intensively studied for its sedative and hypnotic effects, dl-THP at defined low dosages acts as anxiolytics in mice, and the benzodiazepine site (BDS) mediates, at least in part, such anxiolytic effect of dl-THP.^[2]

Tetrahydropalmatine can effectively protect endothelial cells against γ -irradiation injury, which can potentially be applied to the prevention of endothelial cell dysfunctions associated with ionizing irradiation-induced lung injury. ^[3]

DL-Tetrahydropalmatine possesses analgesic effects, it may act through inhibition of amygdaloid dopamine release to inhibit an epileptic attack.^[4]

DL-tetrahydropalmatine acts through the 5-HT₂ and/or D₂-receptor antagonism in the hypothalamus to induce hypotension and bradycardia in rats.^[5]

Levo-tetrahydropalmatine attenuates oxycodone-induced conditioned place preference in rats.^[6]

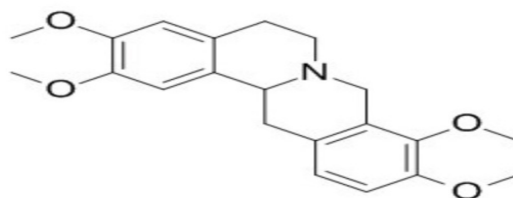
