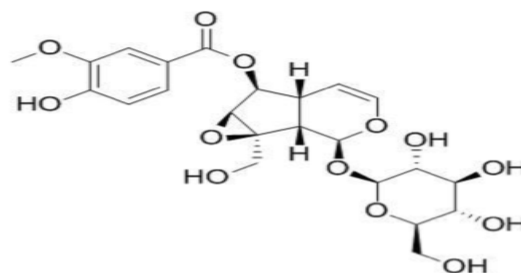

## BIOLOGICAL ACTIVITY OR INHIBITORS

---

Picoside I or II enhances nerve growth factor (NGF)-induced neurite outgrowth from PC12D cells, probably by amplifying a down-stream step of MAP kinase in the NGF receptor-mediated intracellular MAP kinase-dependent signaling pathway.<sup>[1]</sup>

Picoside II (intravenous treatment ) may be beneficial to inhibit neuronal apoptosis and, thus, to improve the neurological function of rats upon cerebral ischemia reperfusion injury.<sup>[2]</sup>

Picoside II can protect hepatocytes against injury and prevent hepatocytes from apoptosis, it may by upregulating the bcl-2 gene expression and antioxidation. <sup>[3]</sup>

Picoside II protects cardiomyocytes against oxidative-stress injury induced by H/R through reduction of ROS production and calcium accumulation and enhancement of the activity of antioxidant defense.<sup>[4]</sup>

Picoside II has anti-inflammatory effect .<sup>[5]</sup>

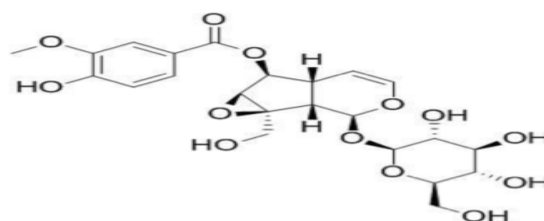
