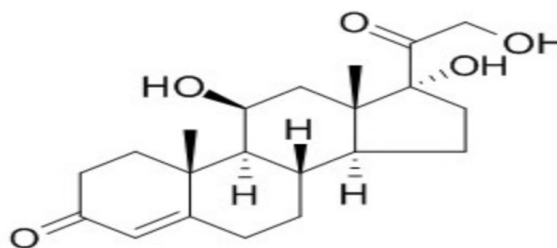

### BIOLOGICAL ACTIVITY OR INHIBITORS

Hydrocortisone does reverse shock faster but there may be an associated increase in econdary infections. [1]  
Hydrocortisone therapy restores hemodynamic stability and differentially modulates the immunologic response to stress in a way of antiinflammation rather than immunosuppression.[2]

Hydrocortisone may reduce the extracellular spread of inflammation through the inhibition of matrix metallopro-  
teinases. [3]

Chronic administration of hydrocortisone leads to deficits in certain tests of cognitive function sensitive to frontal  
lobe dysfunction and may contribute to the cognitive impairment reported in certain neuropsychiatric disorders.

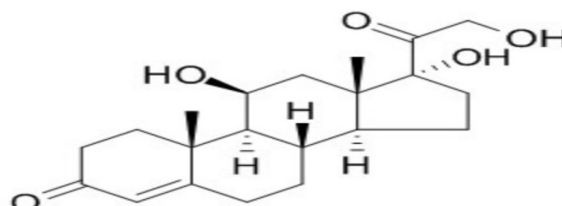
