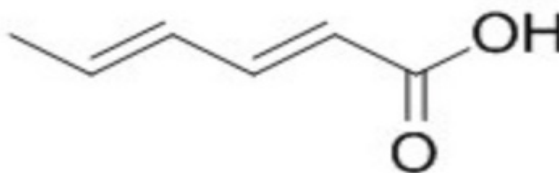

BIOLOGICAL ACTIVITY OR INHIBITORS

Sorbate (sorbic acid) generally is an effective inhibitor of most molds and yeasts and some bacteria.[1]
Food preservatives sodium sulfite and sorbic acid suppress mitogen-stimulated peripheral blood mononuclear cells, they have a suppressive influence on the activated Th1-type immune response.[2]
Sorbic acid has fungicidal activity against *Saccharomyces cerevisiae*. [3]

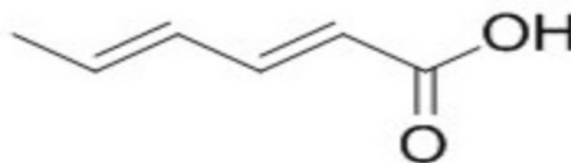
