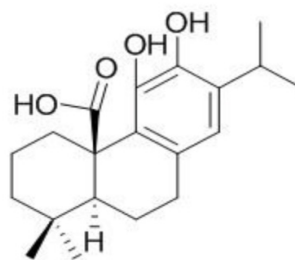

BIOLOGICAL ACTIVITY OR INHIBITORS

Carnosic acid can protect neurons both in vitro and in vivo through activation of the Keap1/Nrf2 pathway via S-alkylation of targeted cysteines on Keap1.[1]

Carnosic acid has antioxidant properties, it is a powerful inhibitor of lipid peroxidation in microsomal and liposomal systems.[2]

Carnosic acid, vitamin C, and vitamin E show photoprotective potential.[3]

Carnosic acid is a class of lipid absorption inhibitor from sage.[4]

Carnosic acid is capable of antiproliferative action in leukemic cells and can cooperate with other natural anticancer compounds in growth-inhibitory and differentiating effects.[5] Carnosic acid has a protective effect on cisplatin induced experimental nephrotoxicity and is attributed to its potent antioxidant and antiapoptotic properties. [6]

Carnosic acid has antimicrobial activity against oral pathogens.[7]

Carnosic acid can inhibit adipogenesis in vitro, and it is a therapeutic agent for obesity-related non-alcoholic fatty liver disease.[8]

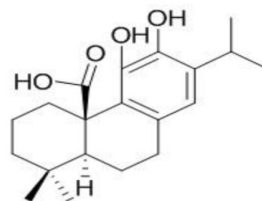
