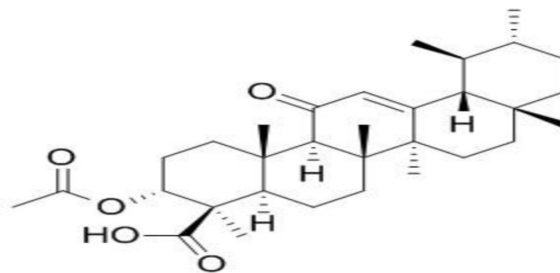

BIOLOGICAL ACTIVITY OR INHIBITORS

3-O-Acetyl-11-Keto-beta-Boswellic acid (AKBA) and its analogs exhibit 5-Lipoxygenase inhibitory properties, they may be used in pharmaceutical compositions for therapeutic applications against a variety of inflammations and hypersensitivity-based human diseases including asthma, arthritis, bowel diseases such as ulcerative colitis and circulatory disorders such as shock and ischemia; they also inhibit the growth of brine shrimp in cultures, which may be considered as a positive indication for cytotoxicity and antitumor activity.[1]

3-O-Acetyl-11-keto-beta-boswellic acid is a novel oral anti-TNF anti-inflammatory agent.[2] 3-O-acetyl-11-keto-beta-boswellic acid is cytotoxic to ovarian cancer cells, it also induces DNA damage and G2/M arrest, which may be related to its cytotoxic effects; it may form the basis of a novel anticancer treatment for ovarian cancer perhaps alongside conventional chemotherapy. 3-Acetyl-11-keto-beta-boswellic acid has anti-inflammatory and anti-arthritic activities, AKBA polymeric nanomicelle gel significantly enhances skin permeability, and anti-inflammatory and anti-arthritic activity.[4]

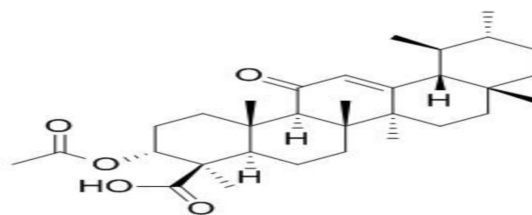
