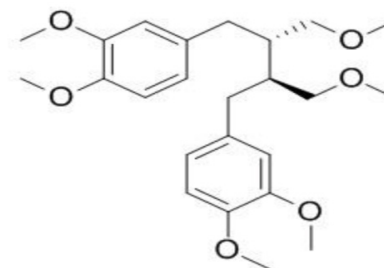

BIOLOGICAL ACTIVITY OR INHIBITORS

Phyllanthin has hepatoprotective effects against ethanol-induced oxidative stress causing rat liver cell damage, through its antioxidant activity.[1]

A mixture (1:1) of Phyllanthin and Hypophyllanthin exhibits antitumor activities against Ehrlich Ascites Carcinoma in Swiss albino mice.[2]

Phyllanthin has antifibrotic potential, it can inhibit CCl₄-mediated oxidative stress and hepatic fibrosis by down-regulating TNF- α / NF- κ B and pro-fibrotic factor TGF- β 1 mediated inflammatory signaling.[3]

Phyllanthin and hypophyllanthin can modulate the vascular tension via the endothelium-independent mechanisms, the modulating effects of both compounds are possibly involved with the blockade of Ca²⁺ entry into vascular smooth muscle cells and inhibition of phenylephrine-mediated Ca²⁺ release from sarcoplasmic reticulum.[4]

Phyllanthin exhibits very high antioxidative property by its low IC₅₀=7.5 μ mol/mL, it also can alter the growth of *C. albicans* and show significant results in vitro.[5]

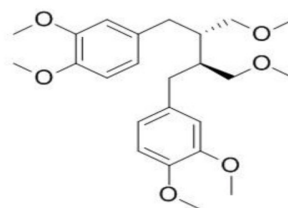
