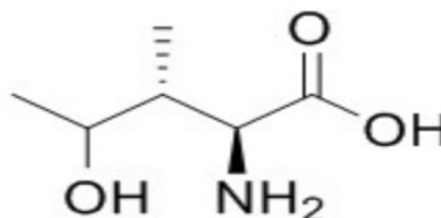

4-Hydroxyisoleucine has antidyslipidemic and antihyperglycemic effects.[2]

4-Hydroxyisoleucine as a useful and well-tolerated treatment for insulin resistance, both directly as a hypoglycemic and also as a protective agent for the liver. [3]

4-Hydroxyisoleucine shows antidepressant-like effects in animal models of depression by brain serotonin turnover enhancement.[4]

4-Hydroxyisoleucine has beneficial effects on low-grade inflammation, it can reverse the insulin resistance by the activation of AMPK and suppression of SOCS-3 coimmunoprecipitation with both the IR- $\beta$  subunit as well as IRS-1.[5]

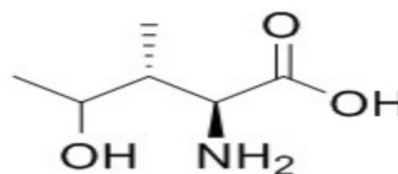
