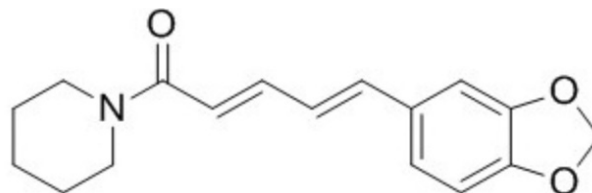

### BIOLOGICAL ACTIVITY OR INHIBITORS

Piperine, a major component of black pepper, inhibits drug-metabolizing enzymes in rodents and increases plasma concentrations of several drugs, including P-glycoprotein substrates (phenytoin and rifampin) in humans, it is an inhibitor of human P-glycoprotein and/or CYP3A4.[1]

Piperine, a known inhibitor of hepatic and intestinal glucuronidation.[2]

Piperine and curcumin are cancer preventive compounds .[3]

Piperine is cytotoxic towards Dalton's lymphoma ascites (DLA) and Ehrlich ascites carcinoma (EAC) cells at a concentration of 250µg/ml, piperine (1.14mg/dose/animal) can inhibit the solid tumor development in mice induced with DLA cells;suggests that piperine has immunomodulatory and antitumor activity. Supplementation with black pepper or the active principle of black pepper, piperine, has tissue lipid peroxidation, can reduce high-fat diet induced oxidative stress to the cells.[5] Piperine has antidepressant like effects in chronic mild stress treated mice, up-regulation of the progenitor cell proliferation of hippocampus and cytoprotective activity might be mechanisms involved in the antidepressant-like effect of piperine, which may be closely related to the elevation of hippocampal brain-derived neurotrophic factor (BDNF) level.[6] Administration of piperine appears to reverse preexisting high-fat diet (HFD)-induced hepatic steatosis and insulin resistance, probably by activation of adiponectin-AMPK signalling in mice. [7]

Piperine has anti-inflammatory, antinociceptive, and antiarthritic effects in human interleukin 1β-stimulated fibroblast-like synoviocytes and in rat arthritis models, thus, piperine should be further studied with regard to use either as a pharmaceutical or as a dietary supplement for the treatment of arthritis.[8]

Piperine shows a lower hepatoprotective potency than silymarin(a known hepatoprotective drug).[9]

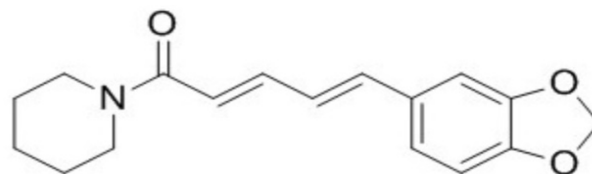
