beta-Carotene has antioxidant activity.[1]

Dietary supplementation of carotenoids may act as moderate hypocholesterolemic agents, secondary to their inhibitory effect on macrophage 3-hydroxy-3-methyl glutaryl coenzyme A (HMGCoA) reductase, the rate limiting enzyme in cholesterol synthesis.[2]

beta-Carotene has antiapoptotic and antioxidant effects against methotrexate-induced testicular injury.[3] beta-Carotene and linoleic acid have inhibitory effect on the in vitro growth of human cancer cells, they may be cytotoxic to human cancer cells in vivo.[4] beta-Carotene, chlorogenic acid, and curcumin have protective effects against gamma -radiation-induced in vivo chromosomal damage.[5]
