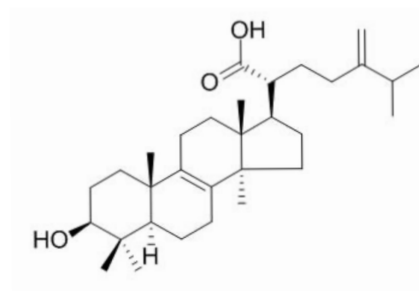

### BIOLOGICAL ACTIVITY OR INHIBITORS

Eburicoic acid and dehydroeburicoic acid from *Antrodia camphorata* have hepatoprotective effects against carbon tetrachloride (CCl<sub>4</sub>)-induced liver damage were investigated in mice, they protect the liver from CCl<sub>4</sub>-induced hepatic damage via

[1] inflammatory cytokines and an increase of antioxidant enzyme activity.  
Eburicoic acid can effectively reduce Hep 3B cell viability within 24 hours, and the IC<sub>50</sub> was 18.4 μM, which is equivalent to 8.7 μg/mL; it firstly promoted reactive oxygen species generation and ATP depletion, leading to endoplasmic reticulum stress, followed by elevated cytosolic calcium ion concentration and BiP expression, down-regulated phosphorylation of DAPK, upregulated phosphorylation of Beclin-1, JNK, and Bcl-2, and finally induced autophagy in Hep 3B cells; indicates that eburicoic acid has significant antioxidant and anti-inflammatory mechanisms.

Eburicoic acid and dehydroeburicoic acid have analgesic and anti-inflammatory effects, the anti-inflammatory mechanisms of them might be related to the decrease of

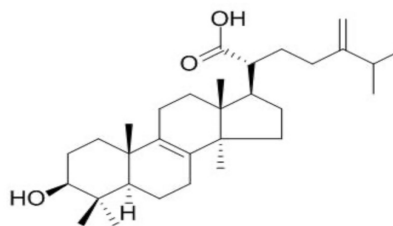
