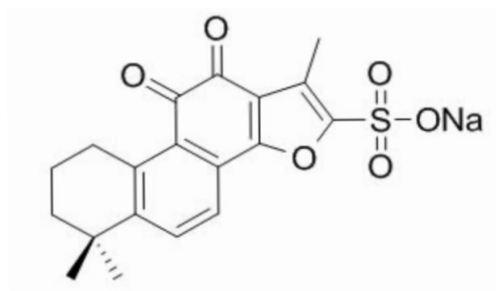

Intravenous Sodium Tanshinone II A sulfonic acid inhibits intimal proliferation after arterial balloon injury in rabbits, the effect can be partially explained by the induction of apoptosis in injured artery; sodium tanshinone-II A sulfonic acid may be of potential therapeutic value in the prevention of restenosis after angioplasty.

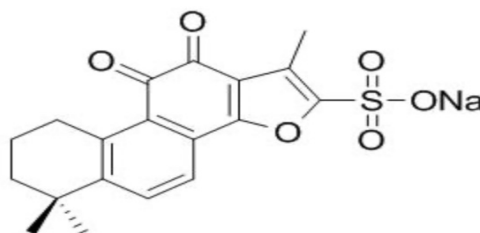
